In the summer of 1997, the City of Charlotte replaced the Mint Randolph roof in an effort to reduce leaks; but with the shifting of weight from the roof, the glass fronts of the cases of the Delhom Gallery came partially out of their channels, and the glass bowed. The gallery was appropriately closed and made safe.

Summer rains brought a flood to the warehouse on 36th street, and the museum lost archival records, supplies of stationary and catalogs, as well as props and stored decorative items of the affiliates. The reserve collection of the North Carolina pottery and the Chasanoff collection were also stored in the warehouse, but damage was minimal.
